Southern Hospitality welcomes you to Paradise Acres. Nestled in the quiet community of Gray's Creek, North Carolina, Paradise Acres is a 12-acre private park filled with several different activities to entertain all age groups.

Included in the Park rental is the Main Pavilion. The minimum number of people required to rent the Pavilion is 75. This location is perfect for Corporate Events, Organizational Days, Reunions, Holiday Celebrations, etc. Inside the Pavilion are tables and chairs, a stage area, bar area, and restrooms. The Pavilion is not air-conditioned but does have large fans. The Pavilion is an enclosed building, but does open on one side, weather permitting. We do have heating during the cooler months.

The rental hours for Private Events at Paradise Acres Park / Main Pavilion are 10AM – 10 PM Monday – Thursday, 11AM – 3PM Fridays and Saturdays and 4PM – 9PM Sundays for \$125.00 per hour. Parties for more than 500 people, require \$1.50/person rental fee. A deposit is needed to secure your date at Paradise Acres and should equal the cost of your rental price. This deposit is non-refundable nor transferable except for severe inclement weather.

Also included with the rental of the Park, we offer a large children's playground, open field, corn-hole boards, walking track, beach volleyball, basketball court and horseshoe pitching. All equipment is furnished for these activities, but you are welcome to bring board games, BINGO cards, etc.

Train can accommodate both adults and children. Castle Bounce is for children only. Fishing Hole is "Catch and Release". Paradise Acres supplies Cane Poles, live bait and assistance. Guests may bring personal fishing equipment, except for minnows. Children ages 10 and under must always be accompanied by an adult in the Fishing Hole. Super Slide is 18 feet tall and will accommodate children and teenagers. ***Three (3) or more of Paradise Acres' attractions must be rented before any outside vendors will be allowed to do business at Paradise Acres. For the safety of our guests, any outside vendors will need prior approval from Paradise Acres and show proof of insurance.

CONTRACT FOR SERVICES

Meal Service Information:

Headcount: Paradise Acres works on a guaranteed number of guests for each event. Food will be ordered and prepared for this number. This number needs to be given to Paradise Acres no later than ten (10) days before your event for preparation purposes. This number may be increased up to three (3) days before your event to accommodate additional guests. Paradise Acres will count out plates equaled to the headcount provided. Once everyone has gone through the buffet, we will count the plates and inform the Point of Contact of their actual number of guests. Paradise Acres prepares plenty of food to accommodate second helpings on Buffet services. Paradise Acres does not count those wishing to have second helpings in the initial headcount.

Additional Guests: If additional guests arrive, we will expect payment for those guests before the end of the event.

If the headcount number is not met on the day of the event, the food for the number of people short will be boxed up by our Staff and given to the Point of Contact at the end of the event.

Paradise Acres prepares food for consumption during the meal service hour only. If you would like everyone to take a plate home as well, you will need to double your headcount. Once your headcount has been satisfied, the remaining food will be taken from the buffet line for Paradise Acres to dispose of unless otherwise discussed with the Point of Contact. Please remind your guests that we do not allow “doggie bags” / “wrapped plates” due to health regulations. Food will be served for one hour unless otherwise discussed with Management.

Deposit / Rental Information:

A deposit **equal to your rental cost** is required for customers who wish to secure their date for the Pavilion at Paradise Acres. The deposit will be applied to the total bill. If the event is cancelled, once the deposit is made, the deposit cannot be refunded.

Paradise Acres Pavilion – \$125.00 per hour up to 500 guests. For events expecting more than 500 people, the amount of the rent is \$1.50 per person. Ex./ 600 people attending your event, the rent charge is \$900.00.

Alcoholic Beverages:

All sales of beer and wine will be handled by Paradise Acres. No outside beer or wine may be brought onto the premises as per the NC ABC Board. Please inform Paradise Acres if you would like a cash bar to be set up for your event when your headcount is given (10 days beforehand) so alcohol may be ordered from our vendors. If you would like to provide your guests with fortified liquors, you will need to purchase a “Limited Special Occasion Permit” issued by the North Carolina Alcohol Beverage Commission and will need to provide a bartender. Taxes:

Unless otherwise noted, all customers will be charged the following taxes: 8% tax added to all food items; 7% tax added to all rental items.

Decoration / Set-up Time/ Cleaning Policy:

Each customer is allotted two (2) hours free of charge prior to the event for decorating or setting up. Any time used over two hours will be charged 125.00 per additional hour. The removal of decorations is the responsibility of the customer and must be done within your rental time. The Paradise Acres Staff will clean the Pavilion and Park after your event. All we ask is that our guests clean off their tables and use the trashcans provided throughout the park and inside of the Pavilion.

Marketing:

Please initial if consenting to the following statement:

_____ I understand that Paradise Acres may use videos/photos of my event for the purpose of marketing.

Inclement Weather Policy:

No refund is given due to inclement weather. However, if outside attractions are rented, a refund will be given if the attraction has not been in operation for any length of time. **Once the attraction has begun operation, no refund is given.** In the event of a forecasted natural disaster (hurricane, tropical storm, etc.) a “rain date” may be agreed upon at least **72 hours** prior to the event.

Payment Information:

Paradise Acres accepts business/certified checks, Visa, MasterCard or cash. A 3.78% Merchant Services Fee will be applied to payments made by credit card. Payment for services is due **1 week before the day of** your event. Interest may be charged to payments made after the event date, unless agreed upon prior to the event. Gratuities are not included in your invoice but may be given at the discretion of the customer.

Paradise Acres maintains the right to withdraw from this contract, if customer changes any of the event details already agreed upon, including location, menu selections, guest count, start and ending times, or anything that interferes with health department rules and/or state laws.
